

Terms and Conditions

Superloop Probiz nbn Enterprise Ethernet 2 Months Free Offer

The Offer

1. **Get rewarded!** Get 2 months free worth up to a maximum of \$1,598 (Ex GST) when:
 - Signing up to a New Superloop Probiz NBN EE service on selected Superloop Probiz nbn Enterprise Ethernet plans for a 36-Month Contract term; or
 - Resign/recontract an Existing eligible Superloop Probiz NBN EE service on selected Superloop Probiz nbn Enterprise Ethernet plans for another 36-Month Contract term (**Offer**).

Upon successful activation of a new Eligible plan or re-contracting of an existing Eligible Plan as set out in the table below, the first 2 months of the Monthly Recurring Charge (**MRC**) of your selected Eligible Plan will be free. The total Offer Value that you will receive will be equivalent to two (2) times the MRC of the service. This will vary depending on the service tier chosen at the time of contract.
