Superloop Modem Terms

The Offer

1. Customers will receive one (1) Amazon eero 7 WiFi router, one (1) TP Link VB433v WiFi 7 Gateway Router or (1) Amazon eero Pro 7 WiFi router for zero cost upfront when they stay connected to an Eligible Plan for 24 months. The 24-month term requires that the Customer maintains an active Superloop nbn® or Other Fibre broadband plan as set out below. The zero-cost upfront offer will only apply to the first device and not any subsequent devices which must be purchased outright or by monthly instalment (**Offer**). Please note that the \$25 device shipping charge is payable by the customer. For details on the shipping charges, please refer to the Superloop website.
2. The Offer is available to Superloop Customers with an active, eligible residential or SMB nbn® or Other Fibre plan as below and other plans Superloop provides at its discretion (**Eligible Plans**):
